

## VETERANS COURTS IN ARIZONA

If you are arrested in Arizona you may be eligible for a Veterans Court. By the time you complete arraignment, you should have been advised if that jurisdiction has a Veterans Court. If so, you should “automatically” be considered for that court. THIS DOES NOT ALWAYS HAPPEN!

Review the following list. If you think you qualify for Veterans Court, contact a person listed in the specific Veterans Court, or request consideration by any officer of the court.
